Rental Fee Schedule

Rental of the Entire Camp and/or Multiple Buildings:

- · A rental fee of \$12.00 per person per day will be assessed.
- In addition, a non-refundable deposit of \$600.00 is required.

Rental of the All-Weather Dormitory Only:

- A rental fee of \$12.00 per person per day will be assessed.
- In addition, a non-refundable deposit of \$300.00 is required.

Rental of Recreational Vehicle (RV) sites:

- A \$20.00 per unit per day fee for RV hookups will be assessed. This includes water and electric service and the usage of restroom and shower facilities located on the camp grounds. No sanitary disposal is available or allowed on the property.
- If usage of camp restroom and shower facilities is not required, a \$15.00 per unit per day fee for RV hookups will be assessed.
- In addition, an applicable non-refundable deposit (see above) is required for use of other buildings and/or facilities.

The following guidelines are also applicable. Some are also included in the contract but are stated again here for clarification:

- The written contract between the Owners and Renters shall be signed and the fees and deposit
 paid 30 days in advance of the scheduled event. Before any usage of the facility is allowed, all
 funds must be paid in the form of a Cashier's Check, Money Order, or other Certified Funds
 payable to the Bethel Ministerial Association or Bethel Youth Camp and in the BMA Treasurer's
 possession. No exceptions are allowed.
- The Proof of Insurance (Declaration Sheet) must accompany the signed contract and payment. It must include a Liability Release, with a hold harmless clause for the BMA and a medical insurability clause for all attendees of the scheduled event.
- The non-refundable deposit is used to cover routine set-up and clean-up expenses. Any damage costs, additional clean-up, or other incurred expenses will be charged to the Tenant accordingly.

- A dumpster fee, possibly up to \$500.00, will be determined and assessed following the completion of the scheduled event.
- The Tenant agrees to honor and abide by the Statement of Faith of the Bethel Ministerial Association, Inc.
- 6. Illegal drugs and alcohol are not permitted at any time on BMA property.
- 7. No smoking is permitted on BMA property. There are no exceptions.
- No firearms and/or weapons are permitted on BMA property. Law enforcement officials will be notified immediately upon disclosure.
- Sexual misconduct is a crime. Do not permit any form of this behavior during the scheduled event. In the event of an occurrence, contact the proper authorities, the insurance company, and the BMA immediately.
- 10. Additional rental fees for registrants not included in the original payment must be paid to the BMA on at least a daily basis for the duration of the days of the scheduled event.
- 11. The signed contract, payment in full, and Proof of Insurance should be sent to:
